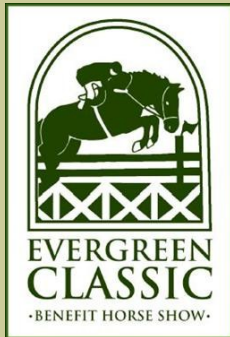

Thank you for participating in the Foundation's Scholarship program in 2010. We received applications from twelve riders this year who will be splitting \$10,000 in scholarships, which represents roughly \$0.26/mile travelled per event (see attached disbursement overview).

The Foundation conducted several fundraisers at this year's Evergreen Classic to raise the funds to pay these scholarships. Thanks to the generosity of Andrea Hutton and the Consignment Ladies, who donated their entire inventory of used clothing to the Scholarship Fund, we sold \$1968 of "recycled" riding apparel. Saturday night's silent auction brought in \$4245. Glassy Babies sales raised \$560. The Stuffed Pig raffle raised \$800 and entries from the Team Power/Speed and Horseless Jumping classes raised an additional \$1455. Thank you to all of the Board Members and Junior riders that donated their time to make this happen.

The Boards of the Foundation congratulate you on your achievements in 2010 and wish you the best in 2011.
